NOTICE OF APPELLATE COUNSEL (NORTH CAROLINA RULES OF APPELLATE PROCEDURE)

Appellants and appellees will receive notification of this date. The appellee's brief is due within thirty (30) days after service of the appellant's brief. The appellant may file and serve a reply brief within the times set out in Rules 13 and 28(h) of the appellate rules.

You will be notified by a copy of the calendar of the date your case is scheduled for argument. The calendar will be sent to you not less than twenty (20) days before your case is scheduled for argument.

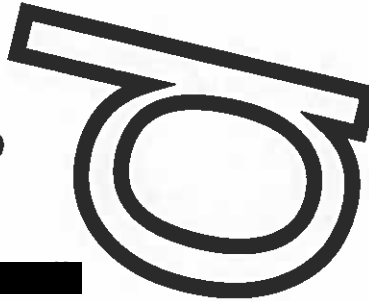
